This guarantee/agreement is limited to the following:

1. This puppy / dog is a purebred German Shepherd Dog that is eligible for registration with the AKC and the buyer will be provided with the American Kennel Club Official Ownership Registration Form.
2. 7 day warranty:
  - a. The Buyer shall have a licensed veterinarian check the puppy / dog within 72 hours of the time of sale and shall provide a certification of the health examination to Snow Shepherd Farms within five (5) calendar days of the date of sale otherwise this warranty is null and void. Text a (legible) picture (MMS) of the veterinarian's invoice to the Seller's phone number or mail a copy to the Seller's address.

b. If your puppy / dog dies within 7 days of purchase, the buyer shall have a necropsy performed to determine the cause of death. The necropsy report must be signed by a licensed veterinarian and a copy provided to Snow Shepherd Farms otherwise this warranty is null and void. If necropsy shows no fault due to Buyer, Snow Shepherd Farms will select and replace the dead puppy / adult as soon as possible with another Snow Shepherd Farms puppy that is less than 6 months old, as long as we are still breeding new litters.

3. 2 year warranty:

a. Hip and Elbow Displasia. Though we have had no instances of hip and elbow displasia at Snow Shepherd Farms we understand that GSD's have a predisposition to this disease and we warrant that this puppy / dog is free of this condition for a period of 2 years (24 months). If a veterinarian recommends euthanasia due to this reason then Snow Shepherd Farms will select and replace the puppy / dog as soon as possible with another Snow Shepherd Farms puppy / dog younger than 2 years old as long as we are breeding new litters.

b. The Buyer shall provide the following to Snow Shepherd Farms: A licensed veterinarian's written certification diagnosing hip or elbow displasia; the vet's recommendation for euthanasia; and the date of completed euthanasia signed by the licensed veterinarian. The Buyer shall provide the licensed veterinarian's name, phone number, mailing address, email address and the name of the veterinarian clinic.

4. Conditions:

a. The Buyer shall assume full responsibility for the health and veterinary expenses of owning and caring for this puppy / dog including any expense in fulfilling provisions of this warranty.

b. It is the Buyer's responsibility to resolve any disagreements with family, roommates, landlords, people with allergies or any other person or entity that may have complaints or damages resulting from the puppy / dog.

c. Under no circumstance will the Seller Snow Shepherd Farms assume liability for any surgery or medical procedure once the puppy / dog leaves Snow Shepherd Farms either by pickup, shipping or delivery.

d. This puppy / dog is intended to be a companion dog. No guarantee is made, either expressed or implied as to the suitability for any other purpose including but not limited to breeding, show dog potential, train ability, etc.

e. This contract is made only with the original Buyer. If the Buyer transfers ownership of the puppy / dog to another owner, this contract is null and void.

f. This contract does not cover Worms and Parasites. Worms and parasites are common in in young puppies raised naturally by their mothers. We have dewormed all of our puppies at least 3 times and we have the mother and all adult dogs on the property on a monthly preventative. We limit access of

outside canines with a 5 foot fence and gate and do not allow canine visitors. Please follow your veterinarian's recommendations.

g. This dog must have "Snow" or "Snow Shepherd" in its AKC registered name as a condition of sale, and as a condition of this warranty. Otherwise, the conditions of this warranty and agreement are null and void.

h. This warranty does not cover traumatic or mechanical injury.

i. Snow Shepherd Farms requests, under no penalty of contract, a picture of the puppy / dog from time to time (6 months, 1 year old, etc.) with your comments. Buyer agrees that any pictures / comments may be used in whole or part for any purpose including advertisement regarding satisfied Snow Shepherd customers. Send us a picture. We will enjoy it.

5. By signing this contract the Buyer indicates that they have read, understood, and agree to all terms of the contract. This is a binding contract being entered into in the county of Gordon County, Ga, city of Calhoun, Ga, and the state of Georgia between the Buyer and the Seller. In the unlikely event of a legal dispute all matters are to be held in the jurisdiction of of the Gordon County GA Superior Court. Damages may not exceed the total purchase price of the puppy / dog.

6. No other circumstances will be considered for a replacement puppy / dog and no refunds will be made. This sale is final. Snow Shepherd Farms will not accept the return of any puppy / dog under any circumstances due to the risk of diseases that could be contracted outside the property which could harm our other dogs.
